Junco was arrested for second degree trespassing (K. Junco had been trespassed from the property by Sgt. Hobby of the Carrboro Police Department during a previous incident). It was apparent that K. Junco was intoxicated due to the odor of alcohol about her person and her having used the bathroom on herself. She was also charged with intoxicated and disruptive. K. Junco was yelling and cussing in the parking lot in front of and at children. K. Junco was taken to Orange County Jail where she went before Magistrate Koelling. K. Junco was held on a \$250.00 secured bond and given a first court appearance on 08/04/2015 at 1400 hrs.
